

THE BED BOSS® 10 YEAR LIMITED WARRANTY

CONGRATULATIONS!

You have purchased the newest and finest in mattress protection made with the best materials and workmanship available. This Mattress Protector has been manufactured for The Bed Boss®. The Bed Boss® warrants the product to the original purchaser only, for residential use only, from manufacturing defects for a period of 10 years from Date of Purchase. The warranty covers the protector product only. The Purchaser is responsible for all shipping costs to The Bed Boss®. **DO NOT SHIP THE PRODUCT TO THE BED BOSS® WITHOUT FIRST CONTACTING THE BED BOSS FOR INSTRUCTIONS. DO NOT RETURN THE PRODUCT TO THE RETAILER WHERE YOU PURCHASED IT.**

This warranty covers manufacturing defects only. Damage to the product caused by abuse, misuse or not properly following the care instructions will void the warranty. The Bed Boss® is not responsible for any incidental or consequential damages resulting from the use of its products. The responsibility of The Bed Boss® shall not exceed the purchase price of the warranted product. This warranty will only be honored when accompanied by a copy of the original proof of purchase from an authorized retailer, reseller or distributor. This warranty is not available where the mattress protector is used for commercial, institutional or rental purposes.

The Bed Boss® reserves the right, upon the presentation of a product covered by the warranty, to repair or replace with the same. In the event that a particular product is no longer manufactured, The Bed Boss® shall have the right to replace the product with a substitute product that most nearly resembles the warranted item.

ADDITIONAL LIMITED WARRANTY.

If The Bed Boss® mattress protector is purchased at the same time and place with a new mattress from an authorized retailer, The Bed Boss® warrants that its mattress protector will protect the new mattress from stains, on the mattress surface only, for a period of 10 years from the date of purchase of the mattress subject to the following terms and conditions:

The customer must notify The Bed Boss® of a claim within 7 days of occurrence and provide a proof of purchase of the mattress at the time of purchase of The Bed Boss® mattress protector. The Bed Boss® will have the right to have a 3rd party company attempt to clean the stain;

If the cleaning company cannot remove the stain, The Bed Boss® will repair the mattress surface, or replace the mattress, at its discretion, with a replacement mattress of similar quality, but in no event at a cost to The Bed Boss® in excess of \$2,000.00.

The limited warranty by The Bed Boss® for mattresses purchased at the same time as a The Bed Boss® mattress protector does not apply if the Customer does not: 1. follow the procedure for claims set forth above; 2. present the original sales receipt for the mattress and The Bed Boss® mattress protector; 3. provide evidence that The Bed Boss® mattress protector was properly used on the mattress when the stain occurred; and 4. present the mattress manufacturer's written warranty. This Limited Warranty shall be in addition to, but not replace, the manufacturer's warranty for any mattress. The Customer shall pay all service and transportation costs related to replacement of a mattress. This Limited Warranty shall be limited to one claim only for each The Bed Boss® mattress protector and new mattress, after which this Limited Warranty shall no longer apply.

In addition, the Limited Warranty for The Bed Boss® mattress protector and the surface of a new mattress utilizing a The Bed Boss® mattress protector, shall not apply where: 1. The use of The Bed Boss® mattress protector and/or mattress is for commercial, institutional, or rental purposes; 2. damage is caused by failure to comply with the care instructions of The Bed Boss® and/or the mattress manufacturer for cleaning and use, including using improper cleaning materials; 3. The Bed Boss® mattress protector has been neglected, mishandled, or abused (whether in transit or otherwise); 4. stains or other damage caused by nail polish, inks, cosmetics, chemical hair treatments, self-tanning and other tanning related chemicals, bleach, non-food related grease, corrosives, chemicals, alcohol, or dyes; 5. stains or other damage caused by dealers or occurring prior to or during delivery or while the mattress is in or being moved into or out of storage or being moved between residences; 6. cuts, punctures, or other damage caused by sharp objects that penetrate The Bed Boss® mattress protector; 7. stains or other damage caused by, or the result of, mold or mildew; 8. damage caused by animals, including beaks, teeth and/or claws/nails; 9. stains or other damage caused by or related to fire (including water damage), smoke, flood or other natural disaster and Acts of God, theft, vandalism or other crime, or any other loss that is covered under an insurance policy; 10. stains or other damage caused by structural problems or appliance malfunctions such as, but not limited to, leaks from air conditioners, skylights, roofs, water heaters, or water pipes; 11. normal soiling, wear and tear; 12. The Bed Boss® mattress protector or mattress purchased as "used" or "as-is"; 13. odors or stains of unknown origins; 14. medical conditions including incontinence; 15. ironing, burns, improper cleaning or failure to clean; 15. accumulating stains over time; or 16. claims under this warranty where Customer failed to report the damage within 7 days of the incident. Also not covered are the sides of the mattress, linens, foundation, box spring or mattresses not fitted with The Bed Boss® mattress protector.

This warranty is the sole warranty given by The Bed Boss®, and shall extend only to the Purchaser. FOR SALES TO ANY PURCHASER OTHER THAN A CONSUMER PURCHASING FOR HOUSEHOLD USE, ALL IMPLIED WARRANTIES, INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE OR USE, ARE EXCLUDED AND DISCLAIMED. IN NO EVENT SHALL THE BED BOSS® BE LIABLE TO ANY PURCHASER FOR INCIDENTAL, CONSEQUENTIAL, PUNITIVE OR OTHER INDIRECT DAMAGES, EVEN IF THE BED BOSS® IS ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. The remedies provided herein are the sole and exclusive remedies of the Purchaser and no one is authorized to assume or undertake for The Bed Boss® any other liability in connection with the sale of the Product. Some jurisdictions do not allow the disclaimers of implied warranties or the exclusion or limitation of incidental or consequential damages, so the above limitations may not apply to you. In the event that the disclaimer of implied warranties is not applicable to you, then such implied warranties shall only remain in effect during the applicable Warranty Period. This warranty gives you specific legal rights and you may have other rights which vary from state to state. This warranty is non-transferable. This warranty shall be interpreted in accordance with the internal laws of the State of Tennessee, without regard to the provisions concerning the conflicts of laws.

The Bed Boss® reserves the right to revise the warranty it offers in connection with the sale of products from time to time. Accordingly, the warranties set forth in this certificate apply only to the Product accompanied by this warranty certificate.
